



Information on Data Processing in Accordance with Art. 13 GDPR

The project participants of the Greifswald Imaging Round Table (GIRT) would like to exchange information via a wiki. Users require a login to use the wiki. This can only be assigned by an administrator. Self-registration is not possible. If you are a project participant and would like to request a login for the wiki, please write an email to wiki-imaging@uni-greifswald.de. By requesting a login, you provide your consent for the processing of your personal data pursuant to the Data Protection Information. The login is then assigned by the administrator.

The general public is unable to access the wiki.

For communication purposes within the project, the surname, given name(s), email address and work address of the GIRT participants are stored on the University of Greifswald's central home directory.

Personal data provided in the wiki's content is also processed. Your username will be displayed on every article that you write or edit on the wiki. Furthermore, your name and contact details may be displayed if you are named as a contact for certain areas.

If you would like to terminate your use of the wiki, please inform us via the email address wiki-imaging@uni-greifswald.de. In such cases, your access to the wiki will be blocked and your username is anonymised in the system. Please also make sure that for all of the devices or software for which you have been named as a contact, you are replaced by another contact (they must have provided their permission for this), or deleted without replacement if you no longer wish to be named as contact after leaving the wiki.

Purpose of data processing:

Login for access to the wiki, identification within the wiki, project-related communication, creation and editing of articles

Type of personal data:

Surname, given name(s), work address, work email address, username, content data, log file data



Storage of personal data:

The data remains stored for as long as the underlying reason for the co-operation exists. If a participant leaves, their access to the wiki will be blocked and their username is anonymised in the system. All of the other personal data and project-related communication will be deleted at the same time.

Legal basis for the processing of data:

Art. 6(1) lit. a GDPR serves as the legal basis for the processing of personal data on the basis of your consent (e.g. communication via email, creation and management of user accounts, content data such as naming in posts).

Log files

The following data is stored in log files every time a visitor accesses our website for reasons related to data security and for statistic purposes:

- IP address
- Time website was accessed
- User agent (browser and operating system)
- Visited pages or content
- Referrer URL, if provided (page visited previously)

The purpose of logging is to recognise, limit and eliminate malfunctions and to detect misuse in accordance with § 12(1) and (4) TDDDG. The IP addresses are not merged with other data sets. The data is stored for a maximum of seven days.

Cookies

When visiting our website, so-called 'session cookies' will be sent to and stored on your device. The legal basis for this is stipulated in § 25(2) TDDDG. Cookies are small text files that are used to make the internet more user-friendly, efficient and secure. They do not damage your computer and contain no viruses. Session cookies are usually deleted automatically after you have left our website. You can deactivate the storage of cookies by changing the corresponding settings in your browser. Please note that deactivation can mean that you will not be able to use all of the functions of our website to their full extent.

Your rights with regard to data processing:

You are entitled to withdraw your consent at any time and without having to provide reasons, with effect for the future. The lawfulness of the data processing that has already taken place remains unaffected by the withdrawal of consent. You also have the right to receive information upon request and free of charge about your stored personal data, its origin and recipient, the purpose, and the length of data processing. Furthermore, under certain



circumstances, you have the right to the correction, limitation of the processing (e.g. blocking), deletion, and the data portability of your data.

In addition, you also have the right to submit a complaint to the responsible supervisory authority for data protection, if, in your opinion, your details are not being processed in a lawful manner.
